## Background Research and Context

Bluebell Park is a 201 place school providing Early Years, Primary, Secondary and Post-16 provision for students with severe and complex learning needs comprising of pupils mainly from the Knowsley area but including some from other parts of Merseyside. All of our pupils have an Education Health Care Plan. We are currently over-subscribed and have 203 pupils on roll.

We have a staff of over 120 within the school and in addition to this we work closely with multi-agencies who are based on site and have over 30 staff in areas including health, social care, therapy support, speech and language support, family first, buildings maintenance.

Our building is a Pfi build and is a two storey purpose built construction with a wide range of facilities including learner and hydrotherapy pools, sports and performance halls, soft play room, sensory rooms, rebound therapy room, adapted food technology rooms, bespoke outside play areas, sensory / horticultural gardens, a fully accessible play park and multi-use games area.

At Bluebell Park, the needs of our pupils means that we aim to deliver bespoke curriculum delivery to remove any barriers to learning as a result of an individuals learning disability. Consequently, those eligible for Pupil Premium do not feature as clearly due to the complex needs of our pupils. We utilise our Pupil Premium funding to support our pupils in achieving their full potential through targeting the key areas such as independent skills, physical social and emotional development, communication and interaction and functional skills acquired through local community based education. Evidence of the impact of this is seen through case studies and qualitative information as well as quantifiable outcomes.
